## TAX FILING INFORMATION

Federal law prohibits depositing a direct deposit tax refund payment to an account not owned by the tax payer (primary or joint ownership). If OCFCU receives a direct deposit tax refund payment containing a payee name that does not match the member name(s) on the account, the deposit will be returned to the Treasury. The tax payer will still receive the income tax refund, but the refund will be sent as a paper check by mail at a later date.
